ORDINANCE NO. 2025-6

AN ORDINANCE AMENDING ORDINANCE NO. 98-018; CLARIFYING ZONING CLASSIFICATIONS TO THE PROPERTIES SET FORTH THEREIN; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES

WHEREAS, Ordinance 98-018 annexed certain areas into the City of Mountain Home and provided zoning classifications for the annexed properties;

WHEREAS, the legal descriptions for the zoning classifications have created confusion in the proper zoning for particular tracts of real estate; and

WHEREAS, an Ordinance should be passed which clarifies and specifies the zoning of particular tracts referenced in Ordinance No. 98-018.

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOUNTAIN HOME, ARKANSAS:

<u>Section 1.</u> Section 2 of Ordinance No. 98-018 provided, in part, that the following real estate be brought into the City of Mountain Home as C-2 zoning, to wit:

All that part of the SE1/4 NE1/4 North of Highway 62 not presently included in the corporate limits of the City of Mountain Home, Section 17, Township 19 North, Range 13 West.

Section 2. That real estate development, surveys and Planning Commission maps have reflected confusion in the zoning of this area. The following described tracts of land shall be and hereby are zoned C-2, to wit:

See Exhibit "A" attached hereto.

Section 3. That the passage of this Ordinance is needed to clarify existing and future zoning in this area. An emergency is therefore declared to exist, and this Ordinance shall be in effect from and after its passage.



ORDINANCE NO. 98-018

AN ORDINANCE ANNEXING PROPERTY CONTIGUOUS THEREWITH TO THE CITY OF MOUNTAIN HOME, ARKANSAS; ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF MOUNTAIN HOME, ARKANSAS; AND TO ANNEX PROPERTY TO THE CITY OF MOUNTAIN HOME, ARKANSAS AND AFFIXING ZONING CLASSIFICATIONS TO THE PROPERTIES HEREINAFTER SET OUT

WHEREAS, a petition was filed with the County Clerk of Baxter County, Arkansas, by the real estate owner of the land hereinafter described, praying that said lands be annexed to and made a part of the City of Mountain Home, Arkansas; and

WHEREAS, on the 8th day of May, 1998, the County Court of Baxter County, Arkansas, found that said petition was signed by the fee simple owners of the said properties; that the said territory, showing its relationship to the present city, has been filed and made a part of said annexation petition; that said proper notice has been given for the time and in the manner prescribed by law; that said lands and territory should be annexed to the City of Mountain Home, Arkansas, subject to the acceptance of the same by the City Council of said City at the proper time as provided by law; and

WHEREAS, the time fixed by law for appealing from said Order of annexation made by the County Court has expired, and no appeal has been taken from said Order; and

WHEREAS, the same petitioners have petitioned in writing to the City of Mountain Home, Arkansas, praying that said properties be annexed to the Water & Sewer Improvement District No. 3 of the city of Mountain Home, Arkansas, for the purposes hereinafter set out; and

WHEREAS, after due notice as required by law, the City Council of the City of Mountain Home, Arkansas, has heard all persons desiring to be heard and has ascertained that said petition was signed by the owners of the real properties in said territory; and

WHEREAS, a proper petition was filed by the property owners requesting a zoning; that said petition was submitted to the Planning Commission of the City of Mountain Home, Arkansas; that notice of said petition and a public hearing thereon was published in a newspaper having local circulation as required by ordinance; that a public hearing was held; that all remonstrances were heard, after which the Planning Commission recommended that all properties described hereinafter be annexed to the City of Mountain Home, Arkansas.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Mountain Home, Arkansas:

Section 1. That the following described lands in territory contiguous to and adjoining the City of Mountain Home, Arkansas, be and the same are hereby accepted and annexed to the City of Mountain Home, Arkansas.

That the following described property is annexed to the City of Mountain Home, Arkansas, to-wit:

That part of the NE 1/4 SW 1/4 [except that part thereof owned by Norcross Ford, Inc. and Joe Norcross and Jacquetta Norcross, Co-Trustees of the Norcross Family Revocable Trust, UTA dated October 17, 1996], the N 1/2 SE 1/4 and the S 1/2 NE 1/4 South of US Highway 62-412 and US Highway 62-412 Bypass and all that part of the E 3/4 SW 1/4 NE 1/4 and that part of the SE 1//4 NE 1/4 outside the present corporate limits of the City of Mountain Home, Arkansas, North of US Highway 62-412, all in Section 17, Township 19 North, Range 13 West.

Section 2. All property is to be zoned R-1 except the following described lands in Baxter County, Arkansas, to be zoned R-2:

Part of the NE¼ SW¼ of Section 17, Township 19 North, Range 13 West, in Baxter County, Arkansas, more particularly described as follows: Starting at the Northwest corner of said NE¼ SW¼; thence S. 15° 32' W. 58.1 feet to a concrete monument; thence S. 00° 07' W. 493.6 feet to the existing south rightof-way of U.S. Highway 62/412; thence along said right-of-way N. 67° 12' E. 515.81 feet; thence S. 02° 43' W. 10.4 feet to a point on the proposed right-ofway of said highway and the point of beginning; thence along said proposed right-of-way the following courses: N. 68° 12' E. 154.9 feet; N. 69° 28' E. 199.2 feet; N. 75° 01' E. 65.1 feet; thence leaving said proposed right-of-way S. 08° 28' E. 487.0 feet; thence S. 67° 24' W. 531.4 feet; thence N. 02° 43' E. 542.3 feet to the point of beginning, containing 5.32 acres, more or less. Reserving the West 20 feet of the above described tract for a utility easement.

and except the following in Baxter County, Arkansas, to be zoned C-2:

All that part of the SE¼ NE¼ north of Highway 62 not presently included in the corporate limits of the City of Mountain Home, Section 17, Township 19 North, Range 13 West.

Section 3. Extensions to the existing sanitary sewer and waters systems as may now exist may be built to serve the property within the bounds of the above described territory in such manner and with such materials as may be in the best interest of the City.
